PROGRAM OF ACTIVITIES





This document presents the program of activities of the Economic Research & Policy Institute "Finance Think" Skopje for the calendar year 2023. The plan is structured around four pillars of Institute's work:

- research,
- analytics,
- advocacy and communication,
- and capacity building and networking.

1. RESEARCH

Research activities for 2023 have been planned as follows:

1. FISCAST Network: Enhancing dialogue for higher municipal transparency, with focus on para-fiscal charges

The overall objective of the project is to strengthen FISCAST network's monitoring of and partnering with local stakeholders on LSGUs' financial transparency, with reference to para-fiscal charges. This overarching aim is broken down into specific objectives involving concrete interventions on four fronts:

- To enhance capacities of local CSOs and of the FISCAST Network to become active stakeholders in the municipal financial transparency processes;
- To improve municipal budget and para-fiscal charges transparency;
- To establish evidence-based, multistakeholder policy dialogue for monitoring of financial transparency and building effective municipal policies;
- To increase public awareness about the benefit that higher transparency, accountability and sustainability have for citizens and businesses, in their roles and capacities to act at the local level.

2. Gender-responsive planning at local level: The case of Prilep and Krushevo

The overall objective of the action is to encourage gender-responsive planning that responds to the different needs of women and men at local level. The action will be aimed at including gender in the programming through concrete interventions on three fronts:

• Improving the accountability of local

governments in implementing their commitments to gender equality;

- Empowering local women and men to express their needs and priorities through the process of participative planning
- Strengthening local stakeholders with capacities for monitoring the gender-responsive planning process.

3. The perfect storm: Food and energy insecurities threaten the economies of the Western Balkan

The main goal of the project is to generate evidence and foster a policy dialogue for the food and energy insecurities in the Western Balkan economies pertinent to four key fronts: household livelihoods, firms' competitiveness, fiscal space and the regional integration. The specific objectives include:

- To employ and empower the WEBecon network with respect to the national and regional policymaking processes on food- and energy-related policies, by generating evidence on the effects of the crisis on the WB economies and on the regional integration;
- To enhance the policy dialogue and cooperation on energy and food supply security, by creating space for wide stakeholders' consultations and networking at the regional level;
- To increase the public awareness for the importance, consequences of and solutions to the food and energy crisis, including through regional approaches.

4. Action on the move: Monitoring, assessment and proposals for anticrisis measures in conditions of a tight budget

The general goal of the action is to analyse and monitor budget spending for anti-crisis measures, at the national and local level, and to propose modification and/or new measures in conditions of an emphasized need for rationalization of public money spending. The specific objectives include:

- To analyse and monitor budget spending for existing anti-crisis measures, in three segments: 1) measures to protect the standard of citizens, at the national and local level, 2) measures to help companies, 3) measures in the area of agriculture and security food, and in the context of effective and efficient spending of public money;
- To make proposals for the modification of existing and new measures, based on the need for their targeting and for the rationalization of budget spending in conditions of "expensive money";
- To raise public awareness of the need for fiscal consolidation and rational spending of public money in the face of multiple crises.

5. Knowledge, measures and policy dialogue for child protection from the food and energy crisis and a sustainable design of policies related to multi-dimensional child poverty

The primary objective of the project is to generate evidence about the impact of the food and energy crisis on overall and child poverty, as well as food and energy poverty, which will be used as a background for designing a roadmap for policy measures at national level. The secondary objective of the project is to increase capacities of the State Statistical Office for multidimensional child-poverty routine measurement and monitoring, to establish a multi-dimensional stakeholder mechanism for designing more coherent policies and to increase stakeholders' knowledge and awareness for the importance of multi-dimensional policy approach.

6. Open Balkan: Free regional movement of labor in conditions of shortage of qualified workers?

The goal of the project is to assess how the free movement of (skilled) labor in the Open Balkan Initiative will affect the labor market in North Macedonia, and thus to encourage a reasoned debate and adjustment of policies to maximize benefits and minimize risks. Specific objectives include:

- Generating knowledge about how the free movement of (skilled) labor included in the Open Balkan Initiative will affect the labor market in the country;
- Encouraging evidence-based public debate about the benefits and challenges of the issue;
- Contribution to economic policies related to the labor market and bilateral social security agreements, in the context of the implementation of the requirements of this Initiative.

7. Initiative for more inclusive democracy for marginalized groups

The initiative aims to make participatory democracy more inclusive for young people, women and displaced persons (including refugees, immigrants and internally displaced persons). The activities of the initiative include:

- Workshops and in-person convening among People Powered member organizations to identify best practices for making participatory democracy inclusive;
- Creation of online courses and resource materials to help organizations implement the best practices;
- Development of multimedia stories that bring to life the human impact of this work, to persuade more governments and organizations to make participation more inclusive.

- 5. Improving the economic datasets to be available for analysis purposes by the other NGOs and other interested parties, and presenting those data in an easily understandable format for non-economists;

- 3. Production of videos on the local financial transparency;

- 4. Organization of a closing events on the projects that end in 2023;
- 5. Organization of a workshop on gender-responsive planning and budgeting for local stakeholders from Prilep and Krushevo and workshop on multidimensional child-poverty routine measurement and monitoring for representatives of State Statistical Office;
- 6. Advocating ("fighting for") for more space for economic news in the media by stronger links with them.
- 7. Upgrading web-site www.fiscast.mk and building a web-site on para-fiscal charges at local level.
- 8. Preparing strategic plan for the period 2023-2028.
- 9. Preparing M&E Strategy for the period 2024-2026.
